Website Terms and Conditions

These terms and conditions apply when you access or use the Website of Maven Business Group Pty Ltd (we, us, our) or utilise our Services. These terms and conditions must be read in conjunction with our Privacy Policy, Rental Terms and Conditions (links to the relevant documents are included below). Please read them carefully. If you have any questions or do not understand anything, please contact us.

When you use our website or utilize our Services, you accept and agree to be bound by our terms and conditions.

1. Who may utilise our Services

- a. Our Services are available to individuals over the age of 18 years and, provided they have an ABN, to companies and other entities.
- b. If you are registering for or utilising our Services on behalf of a company or another person or entity, you:
 - i. must be an officer or agent of the company, person or entity authorised to enter into legally binding contracts on behalf of the company, person or entity; and
 - ii. represent and warrant to us that you are authorised to do so and that the relevant company, person or entity has consented.

2. If you register on our Website

To obtain access to certain of our Services you must register on our Website. If you register to use our Website or utilise any of our Services, you:
